### Voting Members

Voting members are companies engaged in providing goods and services to the semiconductor electronic system design ecosystem. Membership entitles your company to vote on the selection of ESD Alliance board members, policies, have employees participate or serve as an officer in ESD Alliance committees and working groups, use of the Alliance's logo in promotions, receive invitations to meetings, and receive all pertinent correspondence.

### Associate/Non-voting Members

Associate members include organizations not actively engaged in providing goods and services to the semiconductor electronic system design ecosystem, but which are associated with and interested in the design ecosystem. Associate memberships do not have voting rights. Associate membership does entitle employees to serve on committees and working groups attend most meetings and receive all correspondence from the ESD Alliance.

### Individuals and Consultants

Individual Associates shall include individuals and consultants with an interest in the activities of the Alliance and in the design ecosystem. Membership entitles individuals to serve on committees, attend most meetings and receive all correspondence with the exception of the MSS subscription which is not included.
